Welcome letter

Dear friends and supporters,

In 2025, AMBER Alert Europe made substantial progress towards our vision of a Europe where the safety and rights of every missing child, and every missing person, come first, and are acted upon. Working across borders and disciplines, we strengthened prevention, training, and the resolution of cases of long duration.

This progress was made possible by the continued growth of our network. Today, AMBER Alert Europe connects 85 organisations across 29 countries, including Ministries of the Interior, police academies, universities, and non-governmental organisations, supported by some of the world's leading law enforcement experts. To further strengthen our impact, we established Europe's first Scientific Advisory Board on missing persons in 2025, ensuring that science, innovation, and evidence-based practice remain at the heart of everything we do.

One of the year's most significant milestones was the launch of our global campaign, Friend or Monster? Reaching families in 29 countries, the campaign helps parents, teachers, and caregivers recognise the early warning signs of abuse. By helping adults identify risks earlier, we aim to prevent harm before it occurs and before a child goes missing.

As a CEPOL Framework Partner, we maintained close working relations with the European Union Agency for Law Enforcement Training (CEPOL), and continued to explore new initiatives to further support law enforcement professionals across Europe. This included developing a new series of webinars on missing-person investigations and cold cases, which will be launched in 2026.

Our International Cold Case Analysis Project (ICCAP), the largest of its kind in the world, opened its eleventh round with more than 300 students from universities

and police academies across the globe, working on real unsolved cases. From missing person investigations to decades-old homicide cases, ICCAP combines academic insight with operational expertise to generate fresh perspectives, new leads, and renewed hope for families who have waited far too long for answers.

As we look ahead to 2026, we are building on our Common European Approach, through digital forensics and AI-driven innovation, by bringing ICCAP's cold-case methodology into CEPOL's EU training, and by welcoming new expertise, including leading minds in artificial intelligence, to our Scientific Advisory Board.

Through these efforts, we are entering the next chapter as a stronger organisation than ever before. Yet our mission remains unchanged: to keep missing persons firmly on the European agenda and to ensure that every investigation benefits from the best available expertise, technology, and international cooperation.

Every new partner, every shared insight, and every reunited family brings us closer to a Europe where the missing are not only found, but truly protected.

What we achieved in 2025



Working Together for Zero Missing Children: AMBER Alert Europe's Impact in 2025

In 2025, we took important steps forward in our mission to protect children and prevent them from going missing. We launched a global prevention campaign, established Europe's first Scientific Advisory Board on Missing Persons, expanded the reach of ICCAP, and continued advocating for stronger action on missing persons at the European level. Together, these efforts brought us one step closer to our goal: Zero Missing Children.

Our 2025 Highlights

PROTECTING CHILDREN THROUGH PREVENTION AND AWARENESS

In honour of International Missing Children's Day, we launched the "Friend or Monster?" campaign across 29 countries, made available in 11 languages. The campaign confronts a troubling reality: eight out of ten sexually abused children are betrayed by someone they know and trust, such as a family member, close relative, or trusted adult within their community. The campaign was developed in consultation and close collaboration with law enforcement, experts and child protection organisations, with the aim to equip parents, teachers, and caregivers with the knowledge to spot warning signs of abuse, hold safe and supportive conversations with children, and report concerns to the appropriate services.

By raising awareness and promoting early intervention, we aimed for the protection of children and prevention from going missing as a result of abuse within their trusted environment.





EU POLICY ADVOCACY

Last year, AMBER Alert Europe continued to bring the challenges surrounding missing children and missing persons to the attention of European policymakers. Drawing on insights from our network of law enforcement agencies, experts and partner organisations across Europe, we highlighted the challenges professionals face when responding to missing-person cases, particularly in cross-border situations.

Throughout the year, we engaged with the European Commission, including DG HOME and DG JUST, to share expertise and contribute to discussions on issues relating to child protection, victims' rights, justice and internal security.

In March, our chairman participated as a panellist at DG HOME's CERIS event on missing persons, where he called for multistakeholder and multidisciplinary unity to tackle challenges related to the

phenomenon of missing. The International Cold Case Analysis Project also featured in the program, with Course Leader Karsten Bettels presenting the project and its added value for victims' rights and law enforcement cooperation.

We also continued discussions with the European Parliament and the Council of the European Union on ways to strengthen the European approach to missing persons. Throughout these discussions, AMBER Alert Europe advocated for enhanced cross-border cooperation and explored how a dedicated European framework could help improve the response to missing-person cases across Europe.

ADVANCING COLD CASE INVESTIGATIONS THROUGH ICCAP

In 2025, the International Cold Case Analysis Project completed two further sessions, with continued growth in participation. To date, ICCAP has brought together more than 1,000 students and professionals from 53 organisations across 12 countries, and has analysed over 60 cold cases, building real expertise in long-duration case work and the needs of victims and families awaiting answers.

A significant development in 2025 was the strengthening of ICCAP's policy dimension. By combining academic expertise, law enforcement cooperation and structured methodologies across disciplines such as law, criminology, forensic science and psychology, ICCAP continues to demonstrate the added value of multidisciplinary review processes in support of justice, victims' rights and investigative practice across Europe. Findings on victims' rights and lessons from cold case review were brought to the attention of the European Commission and Members of the European Parliament, including representatives of the LIBE Committee, ensuring that the insights generated through ICCAP reach those with the power to strengthen Europe's investigative and legal policy framework.

One of the highlights of the year was ICCAP winning the Dutch Police and Public Prosecutor's Office Hackathon for the second consecutive year. In just six hours, the ICCAP team analysed thousands of pages from a real cold case using a stand-alone, safe, offline AI model configured to simulate a cold-case investigator with 20 years of experience. The result demonstrates how responsible AI can accelerate cold-case analysis without compromising security, and reinforces ICCAP's role as a proven link between academic expertise and real investigations.

By combining academic knowledge with law enforcement cooperation, ICCAP continues to give forgotten cases renewed attention and support the families who need it most.



LAUNCHING THE FIRST SCIENTIFIC ADVISORY BOARD ON MISSING PERSONS IN EUROPE

AMBER Alert Europe launched the first-ever Scientific Advisory Board on missing persons in July 2025, bringing together leading academics at the forefront of research into missing persons and the underlying issues that contribute to disappearances. The Board is unique in Europe: the first fully dedicated to this topic, selected from our extensive academic network of universities and police academies across the continent.

This milestone built on a process that began in early 2024, when the Foundation deepened its engagement with the academic community, recognising the importance of grounding its policy advocacy and operational work in robust, evidence-based expertise. Through consultations with reputable academics across Europe, it became clear that a dedicated scientific advisory structure would significantly strengthen the quality and credibility in policy advocacy messages of our work.

The founding members, from Germany, Belgium and the United Kingdom bring together expertise from disciplines including human rights, law and forensic psychology. As the Board continues to grow, the Foundation is placing increasing emphasis on evidence-based research across both its policy advocacy and its projects. The ability to consult leading academics on pressing European challenges, and to receive independent expert advice, has significantly strengthened AMBER Alert Europe's work and strategic vision in support of its mission of zero missing children.

STRENGTHENING CROSS-SECTOR PARTNERSHIPS

In 2025, partnerships were one of the key areas of strategic development for AMBER Alert Europe. The Foundation's network expanded significantly, now bringing together 85 participating organisations united by a shared commitment to protecting missing children and missing persons, as well as tackling the risks to child safety.

This growth reflects the wide range of expertise that effective action on missing children requires. We continue to nurture multistakeholder and multidisciplinary partnerships, recognising that cooperation across academia, law enforcement and civil society is essential to prevention, protection, research and policy advocacy. The Foundation remains open to proactive cooperation with organisations willing to join forces and develop initiatives aligned with our mission.

The growth of the network strengthens the Foundation's impact as a pan-European organisation. A significant share of the new participating organisations are universities, which has deepened our connections to academic expertise and evidence-based research across Europe. This supports the Foundation's ambition to ensure that its prevention work, projects and policy efforts are built on the best available evidence-based research and scientific insight, helping to drive real progress for missing children and their families.

SUPPORTING LAW ENFORCEMENT THROUGH TRAINING

In 2025, we continued our cooperation with CEPOL as an official Framework Partner, strengthening relationships with key stakeholders in European law enforcement training and capacity-building.

Throughout the year, we worked closely with CEPOL Headquarters in Budapest to explore how our cooperation can continue to evolve and create added value for professionals working on missing-person cases across Europe.

Building on our expertise in missing children, missing persons and cross-border cooperation, we engaged in discussions on emerging training needs and opportunities to further support the European law enforcement community. These conversations focused on how knowledge from law enforcement, academia and civil society can be brought together to strengthen professional practice and improve cooperation across borders.

We also consulted with the team of European Commissioner Brunner on future law enforcement training needs, and the role civil society organisations can play in supporting child protection, public safety and European cooperation.

By maintaining strong partnerships and sharing expertise, we continue to contribute to a more connected and collaborative European response to missing children and missing persons.



LOOKING AHEAD

2025 was a year of prevention, innovation, and impact. From helping parents and caregivers recognise warning signs to shaping EU policy, from cold-case analysis to new scientific expertise, every initiative brought us closer to our mission: strive towards Zero Missing Children in Europe. Together with our partners, we are building on our Common European Approach — so that every missing child, and every missing person, is better protected, searched for from the very first moment, and given the best possible chance of being found.

About us

AMBER Alert Europe, the European Centre for Missing Children, is a pan-European foundation uniting 85 organisations across 29 countries in the mission towards zero missing children in Europe. We connect law enforcement and justice authorities, interior ministries, civil society organisations, universities, and police academies to protect children from going missing, improve the search for those who do, and address root causes through evidence-based research and best practices.

One goal drives everything we do: #ZeroMissingKids.

We train law enforcement, conduct research, advise on child alert systems, reopen cold cases, run public prevention campaigns, and shape EU policy on missing children.

In 2014, we initiated the informal group of law enforcement officials, focal points on missing persons. The latter group was formalised into the Police Expert Network on Missing Persons (PEN-MP). Today it is officially recognised by the Council of the European Union and connects 80+ law enforcement experts across 34 countries.

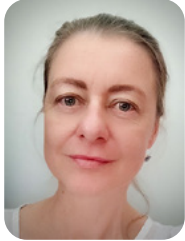
Our policy work helped shape Prüm II, the SIS Recast, the AI Act, and the Council Conclusions on Missing Persons. We are also proud members of the European Commission's AI Alliance and the FRA Fundamental Rights Agency's Platform.

As official CEPOL Framework Partner, we have trained over 1,500 law enforcement professionals across Europe. Our prevention campaigns have reached millions of families in 23 countries. We advise Member States on building AMBER Alert systems that mobilise entire populations within minutes when a child is in danger.

ICCAP, world's largest cold-case project, brings together 1,000+ students from 54 universities and police academies across 12 countries to re-examine unsolved missing persons and murder cases—work that has generated new leads, triggered investigations, and been featured on national television.

General notes

Activities

The activities of Stichting AMBER Alert Europe, having its registered office at Beek primarily consist of:

- Stichting AMBER Alert Europe, having its registered office at Peter Treckpoelstraat 4, 6191 VK Beek, The Netherlands, aims to contribute, on the one hand, to the protection of missing persons in Europe, particularly missing children due to their vulnerability, and on the other hand, to the prevention of disappearances in Europe by undertaking activities that contribute to this goal in any way possible and by carrying out all that is related or conducive to the aforementioned objectives.

The foundation seeks to achieve this goal by:

- a. overcoming barriers in terms of bureaucratic, legal, geographical, or linguistic boundaries. With a view to this objective, the foundation will seek cooperation with organizations that pursue the improvement of safety within European society.
- b. promoting the involvement and participation of relevant governmental and non-governmental organizations, businesses, and civil society to achieve its objective.
- c. supporting national or international police organizations and encouraging cooperation between them for the aforementioned goal.
- d. facilitating and organizing education and training on the subject of missing persons, especially missing children, and closely related topics for a wide range of stakeholders and actors.
- e. engaging in activities focused on prevention and increasing public awareness regarding the subject of missing persons, especially missing children, and closely related topics.
- f. conducting research on the subject of missing persons, particularly missing children, and closely related topics.
- g. upon request from national authorities, contributing to the implementation of an AMBER Alert system and other forms of citizen participation in European member states, or connecting these or similar systems.
- h. launching initiatives aimed at influencing legislation and legal processes in the field of children's rights and other relevant regulations.
- i. carrying out all further actions that are broadly related to or conducive to the aforementioned, provided that the foundation operates independently, neutrally, and based on expertise and evidence.

General accounting policies

General

The financial statements are prepared according to directive RJK.C2 "Kleine fondsenwervendeorganisaties". The Annual Report has been prepared in accordance with directive RJ650 "Fondswervende organisaties van de Raad voor de Jaarverslaggeving".

The annual accounts have been prepared based on the historical cost. Valuation of assets and liabilities and determination of the result takes place under the historical cost convention.

Given that the budget of this foundation is not used as an important steering tool for controlling the activities, the differences between the budget and the balance aren't analyzed.

Comparison with previous year

The valuation principles and method of determining the result are the same as those used in the previous year, with the exception of the changes in accounting policies as set out in the relevant sections.

Exceptional items

Exceptional items are items of income and expense from the normal, non-incidental activities or transactions, but which need to be disclosed separately on the basis of the nature, size or incidental character of the item.

ACCOUNTING POLICIES APPLIED TO THE VALUATION OF ASSETS AND LIABILITIES

Tangible fixed assets

Other tangible fixed assets are valued at historical cost or production cost including directly attributable costs, less straight-line depreciation based on the expected future life and impairments.

Accounts receivable

Receivables are initially valued at the fair value of the consideration to be received, including transaction costs if material. Receivables are subsequently valued at the amortised cost price. Provisions for bad debts are deducted from the carrying amount of the receivable.

Cash at bank and in hand

Cash at bank and in hand represent cash in hand, bank balances and deposits with terms of less than twelve months. Overdrafts at banks are recognised as part of debts to lending institutions under current liabilities. Cash at bank and in hand is carried at nominal value.

Reserves and funds

When the foundation purchases treasury shares, the consideration paid is deducted from other reserves or any other reserve if the articles of association allow so) until the shares are cancelled or reissued. Where such shares are subsequently reissued, any consideration received is included in other reserves or any other reserve. The consideration received will be added to the reserve from which earlier the purchase price has been deducted.

Incremental costs directly attributable to the purchase, sale and/or issue of new shares are shown in reserves and funds as a deduction, net of tax, from the proceeds.

Current liabilities

On initial recognition current liabilities are recognised at fair value. After initial recognition current liabilities are recognised at the amortised cost price, being the amount received, taking into account premiums or discounts, less transaction costs. This usually is the nominal value.



3.3 Notes to the financial statements

PRINCIPLES FOR THE DETERMINATION OF THE RESULT

General

The result is the difference between the realisable value of the goods/services provided and the costs and other charges during the year. The results on transactions are recognised in the year in which they are realised.

Costs

Costs are determined on a historical basis and are attributed to the reporting year to which they relate.

Exceptional items

Exceptional items are items of income and expense from the normal, non-incident activities or transactions, but which need to be disclosed separately on the basis of the nature, size or incidental character of the item for reasons of analysis and comparability of the results.

Financial income and expense

Interest income and interest expenses

Interest income and expenses are recognised on a pro rata basis, taking account of the effective interest rate of the assets and liabilities to which they relate. In accounting for interest expenses, the recognised transaction expenses for loans received are taken into consideration.

Currency translation differences

Currency translation differences arising upon the settlement or conversion of monetary items are recognised in the income statement in the period that they are realised, unless hedge accounting is applied.
